

Thank you for your trust, your commitment, and your belief in our mission. I am honored to walk this path with you and excited to see where it will lead us next.



2023 Highlight

On June 25, 2023, we hosted our 2nd annual Legacy Run/Walk.

Our second annual run was a resounding success. The overwhelming response to the event shows how valuable the run/walk is to support and connect the pregnancy and infant loss community.

In 2023, our fundraising Goal was \$100,000 which we exceeded, raising: \$107,821! The event brought in 462 participants, a 32% from last year's event!

Tiny Footprints Gala



Inspired by the loss her twin daughter, Kristina Oriold and her best friend, Jen Woods, co-founded the Tiny Footprint Gala in 2016 to support those impacted by pregnancy and infant loss. Since 2022, the Tiny Footprints Gala has been planned and hosted by the Pregnancy & Infant Loss Support Centre (PILSC), holding the 8th annual Tiny Footprints Gala in 2023.

The 2023 Tiny Footprints Gala was a heartwarming evening charged by compassion, elegance and connection with \$68,644 raised and 130 gala attendees! The received funds were vital in keeping PILSC support services live and accessible at no cost for individuals and families in need.







Awards & Recognition

2023 was a milestone year for our organization, marked by significant recognition of our impactful work in intersectional restorative social justice and equality. This recognition is a testament to the visionary leadership that drives our mission forward.

No Cost Indigenous Memorial & Ceremony Box


We are so grateful to **Dow Canada** for funding and partnering on a new pilot project: No Cost Indigenous Memorial & Ceremony Boxes. These boxes have been intentionally curated alongside Indigenous community partners and Fiddler Kiss Consulting.

The boxes contain intentional items that allow Indigenous families who have experienced loss to participate in culturally significant memorials or ceremonies. Each item has been meaningfully selected to honor traditional practices and has been blessed by Indigenous Knowledge Keeper Daisy Giroux.

This initiative represents a critical step in our commitment to reconciliation and deepening our support for Indigenous families during their most challenging times. By offering these boxes at no cost, we are actively working to remove barriers and ensure that cultural practices are accessible, respected, and upheld. We recognize that the path to reconciliation involves acknowledging and addressing the unique needs of Indigenous communities, especially in the context of grief and loss.


This project is just the beginning. We are committed to continuing to listen, learn, and expand our support for Indigenous families.


